The CLA employs a registered lobbyist for the state legislature and state agencies, lobbying on behalf of all loggers in NC at the State and Federal level. The following bullet points are a few accomplishments that the CLA is credited with.

- The re-instatement of sales tax exemption on logging equipment
- The removal of the driveway access permit
- Change of the weight limit tolerance by increasing the limit from 80,000 to 90,000 lbs.
- CLA has a written collaborative training alliance between NC Department of Labor (OSHA), NC Forestry Association (NCFA), and Forestry Mutual Insurance Company (FMIC).
- An active engagement with the NC Highway Patrol Division of Motor Carrier Enforcement.
- Represents all loggers in NC as a voting member of the American Loggers Council that is recognized nationally for lobbying predominantly on Federal Issues.
- Obtains a seat on the Board for the Sustainable Forestry Initiative State Implementation Committee. (SFI)
- Active member of the Safety and Logging Transportation Committee.
- Active member of TEAM Safe Trucking.
- Close working relationship with the NC Forestry Service and the Department of Water Quality.
- State sponsor for Log A Load For Kids.
- Actively seeking access to the Interstate Highway System

We contribute this success and the continuation of being a voice on behalf of the industry to our logging members, trucking members, and partner members.
